Whereas, The owners of certain lands in the Towns of Blaine and Leuterville of said Anoka County, upon the petition of Jas. J. Edwell

bearing date the 28th day of May 1890, and on file in my office, praying for the establishment of a public Ditch and its Branches along the route proposed therein,

Now, Therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their meeting in Special ~~regular~~ session at the Court House in Anoka on the 22^d day of November 1890, at 10 o'clock A. M.

The place of commencement of said Ditch and its Branches at its source is as follows:
 Main Ditch commencing at a point on the Section line between Sections 13 & 14 Town 31 Range 23, 649 feet south of the section corner common to Sections 11, 12, 13 & 14 said Town and Range thence northerly and easterly through Sections 13 & 12 in Town 31 Range 23 and Section 7 Town 31 Range 22 to the center of the S.E. $\frac{1}{4}$ of said Section 7 where it joins the Pensee Ditch "so called" thence southerly & easterly down said Pensee Ditch

1 also a Branch known as Branch "B" which commences
 2 on the Section line between Sections 1 & 12 Town 31
 3 Range 23, 117 feet east of the N.W. corner of the N.E. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$
 4 of Section 12, said Town and Range, thence southerly
 5 and westerly through Section 12,

6 Also another Branch known as Branch "A"
 7 commencing at the quarter post on west side of
 8 Section 6, Town 31 Range 22, thence southerly and
 9 easterly through Sections 6 & 7, said Town and Range

 Branch "B" terminating in the main Ditch in the S.E. $\frac{1}{4}$ of Section 12, Town 31, Range 23 at Stake 44 + 27 of said Main Ditch.
 Branch "A" terminating in Main Ditch in the S.W. $\frac{1}{4}$ of Section 7, Town 31 Range 22 at Stake 74 in said Main Ditch. Said Ditch to be No. 10
