ORDER OF COUNTY BOARD

Re: PETITION OF STATE OF MINNESOTA,  
BY JAMES C. MARSHALL, ITS COMMISSIONER  
OF HIGHWAYS, FOR THE RIGHT TO MAKE  
A MINOR ALTERATION OR CHANGE IN  
COUNTY DITCH NO. 13, IN ANOKA COUNTY:

The above entitled matter came on for hearing before the  
County Board of Anoka County, in the County Commissioners' Room in  
the Court House, Anoka, Minnesota, on the 6th day of May,  
1962, at 2<sup>00</sup> o'clock P. M.

The petitioner appeared by Lawrence J. Sobon.

The petitioner presented evidence in support of its petition  
for permission to make a minor alteration or change in Anoka County  
Ditch No. 13, all as shown in the plan sheets and profile sheets  
attached to the petition.

It was made to appear that the minor alteration or change in  
said Anoka County Ditch No. 13, petitioned for by the petitioner,  
would be advantageous or desirable in the maintenance and construction  
of Trunk Highway No. 65.

It was further made to appear that said minor alteration or  
change in said County Ditch No. 13 would in no way impair the  
efficiency or functioning of the drainage system.

The County Board having heard the evidence adduced by the  
petitioner in support of its petition for permission to make a minor  
alteration or change in Anoka County Ditch No. 13, all as shown in  
plan sheets and profile sheets marked Exhibits "A" and "B", and made  
a part thereof, hereby makes its Order consenting to and granting  
permission to said petitioner to make the minor alteration or change  
in Anoka County Ditch No. 13, all as shown in exhibits marked "A" and  
"B" and made a part thereof.

The Board further orders that the petitioner, State of Minnesota,  
by James C. Marshall, Commissioner of Highways, pay to the County of
