TO THE Hon. Board of County Commissioners

I, the undersigned engineer appointed to examine the drainage system above described and report thereon, having first taken the oath and filed the bond required by law, report thereon as follows:

That I made such examination thereof as necessary to enable me to determine the facts with reference to the matters—set forth in the petition in said matter;—specified in the order of appointment;—

that I found that no survey of Ditch # 16
