AUDITOR'S NOTICE OF PENDING OF PETITION.

Whereas, the owners of certain lands in the towns of Blaine, Anoka and Fridley of said Anoka county, upon the petition of Orum Hargrave, Louis Jepson, A. Matushak, Pat. Lyons, R. Van Elsberg, Wm. L. Liebel, Casper Riehl, C. D. Tut-hill, John Dawson, G. P. Murrell and Robert Murrell, bearing date the 27th day of June, 1892, and on file in my office, praying for the estab-lishment of a public ditch along the route pro-posed therein.

Now, therefore, notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their meeting in regular session at the Court House, in the city of Anoka, on the 3rd day of January, 1893, at 10 o'clock a. m.

The place of commencement of said ditch at its source is as follows: Commencing at or near the north line of the nw¹/₄ of section 29, town 31, range 23, thence southwesterly through the w¹/₂ of sw¹/₄ of said section 29, through the w¹/₂ of nw¹/₄ of section 32, through the ne¹/₄ of section 31, and e¹/₂ of nw¹/₄ of section 31, and the sw¹/₄ of section 31, all in town 31, range 23, thence through the se¹/₄ of section 36, town 31, range 24, thence southerly through the e¹/₂ of section 3, town 30, range 24 and sw¹/₄ of said section 3, and terminating in a creek near Michael Casey's house in said section 3, town 30, range 24, as its outlet; this being Ditch No. 17, Anoka county.
