Notice is hereby given, that, on the 9th day of March, 1893, at 10 o'clock a. m., at the County Auditor's office in the City of Anoka, County of Anoka and State of Minnesota, I will sell the jobs of digging and constructing the Ditch No. 17 of Anoka County, established by the Board of County Commissioners of Anoka County, State of Minnesota, by their order bearing date January 3rd, 1893, viz: In sections of 100 feet each, each of said sections to be known and numbered by stakes, as shown by the report of the viewers in said matter, commencing at the one including the outlet, and from thence, successively, up stream to the one including the source; the place of commencement of said ditch is as follows: In the nw¼ of sw¼ of Sec. 29, town 31, range 23, thence southwesterly through Sec. 29, w½ of nw¼, Sec. 32, through Sec. 31, all in town 31, range 23, through s½ of Sec. 36, town 31, range 24, through n½ of Sec. 3, town 30, range 24, and terminating in a creek near Michael Casey's house in said Sec. 3, town 30, range 24, as its outlet to the lowest responsible bidder or bidders, said work to be completed within the time required, and in the manner specified, in said viewer's report. And no bid will be entertained which exceeds more than thirty (30) per cent over and above the estimated cost of the construction, in any case, as stated in the said order; and the successful bidder will be required to give a satisfactory bond, with two freehold securities, for the faithful performance and fulfillment of his contract, and to pay all damages that may accrue by reason of his failure to complete the job within the time required in the contract.
