Whereas, The owners of certain lands in the Towns of Blaine Anoka and Pringle of said Anoka County, upon the petition of Amin Hargrave, Louis Pepson, Matshak Paterson, R Van Elsberg, Mrs L. Siebel, Lewis Richel, G. J. Luthill, John Johnson, E. H. Murrell and Robert Murrell bearing date the 27 day of June 1882, and on file in my office, praying for the establishment of a public Ditch along the route proposed therein,

Now, Therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their meeting in regular session at the Court House in the City of Anoka on the 3rd day of January 1883, at 10 o'clock A. M.

The place of commencement of said Ditch at its source is as follows:

Commencing at or near the north line of the NW 1/4 of SW 1/4 of Section 29, Town 31, Range 23, thence Southwesterly through the NW 1/4 of SW 1/4 of said Sec. 29 through NW 1/4 of SW 1/4 of Sec. 32 through the SE 1/4 of Sec. 31, and E 1/2 of NW 1/4 of Sec. 31, and the SW 1/4 of Sec. 31, all in Town 31 Range 23, thence through the SE 1/4 of Sec. 36, Town 31, Range 24, thence southerly through the E 1/2 of Sec. 3, Town 30, Range 24, and SW 1/4 of said Sec. 3, and terminating in a creek near Michael Lealey's House in said Sec. 3, Town 30, Range 24 as its outlet, this being Ditch No. 17 in Anoka County
