To the Board of County Commissioners of the County of Anoka
State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Ditch or Drain hereinafter described, would respectfully represent that the public health, convenience and welfare require the establishment and construction of a Ditch or Drain will be conducted along the following described route in the Town of airs to the public health, convenience and welfare in said County of and the same will be to-wit: Commencing at of public benefit and utility and the undersigned hereby petition and request the said Board of County Commissioners to cause to be constructed a Ditch or Drain along the route described as follows in the Town of Blaine, Anoka and Fridley in said County of Anoka: Commencing at or near the north line of the NW¹/₄ of S W¹/₄ of section 29 Town 31 Range 23 thence south westerly through the W¹/₂ of SW¹/₄ of said sec. 29; thence NW¹/₄ of NW¹/₄ of sec. 32; thence NE¹/₄ of sec. 31 and E¹/₂ of NW¹/₄ of sec. 31 and the SW¹/₄ of sec. 31 all in Town 31 Range 23; and terminating at thence through the S E¹/₂ of sec. 36 Town 31 Range 24; thence southerly through the E¹/₂ of sec. 3 Town 30 Range 24 and ending at said sec. 3 and terminating as its outlet in a creek near Michael Casey's House in said sec. 3 Town 30 Range 24 as its outlet.

And your petitioners pray that you will proceed to establish such Ditch or Drain and cause the same to be constructed as provided by

Chapter 97 General Laws of Minnesota, 1887.
