That *Orrin Hargrave, A. J. Purmort and Pat Lyons*

are held and firmly bound unto the County of *Anoka* State of Minnesota, in the sum of *Two Hundred* DOLLARS, lawful money of the United States of America, to be paid to the said County of *Anoka* State of Minnesota, its successors or assigns, for which payment, well and truly to be made, we bind ourselves, our heirs, executors and administrators, firmly by these presents.

Sealed with our seals and dated the *24<sup>th</sup>* day of *September* one thousand eight hundred and *ninety two*

The Condition of the Above Obligation is Such, That whereas the above bounden *Orrin Hargrave and others*

have filed a petition with the County Auditor of *Anoka* County, State of Minnesota, praying for the establishment and construction of a public *Ditch*

along the following described route: *in the Towns Blair, Anoka & Snidley commencing at or near the north lined the N.W. 1/4 of S.W. 1/4 of Section 29, Town 31 Range 23 thence south-westerly through the W. 1/2 of S.W. 1/4 of said sec. 29, through W. 1/2 of N.W. 1/4 of Sec. 32, through the S.E. 1/4 of Sec. 31, and E. 1/2 of N.W. 1/4 of Sec. 31 and the S.W. 1/4 of Sec. 31, all in Town 31 Range 23, thence through the S.E. 1/4 of Sec. 36, Town 31, Range 24, thence southerly through the E. 1/2 of Sec. 3, Town 30, Range 24 and S.W. 1/4 of said sec. 3, and terminating in a creek near Michael Casey's House in said Sec. 3, Town 30, Range 24 as its outlet.*

Now, if the said *Orrin Hargrave and others*

shall pay all expenses, in case the Board of County Commissioners of said County shall fail to establish said proposed *Ditch* then the above obligation to be void, otherwise to remain in full force and virtue.
