NOTICE OF PENDENCY AND HEARING ON PETITION, COUNTY OR JUDICIAL DITCH

STATE OF MINNESOTA,
COUNTY OF ANOKA, ss.

In the Matter of the Petition of Merle Gaslin and Others For the Repair and Modification of County Ditch No. 18 of Anoka County, Minnesota.

WHEREAS, The petition of Merle Gaslin and others, bearing date the 5th day of May, 1947, praying for the repair and modification of said proposed ditch, has been filed in my office; and WHEREAS, The Engineer and Viewers duly appointed in said proceedings have all filed their reports in my office as provided by law.

NOW, THEREFORE, Notice is hereby given of the pendency of said petition, and that the same will be heard and considered before the Board of County Commissioners in the court room at the Court House in the City of Anoka in said County, on the 24th day of November, 1947, at 2 o'clock P.M. All persons interested in the repair and modification of said proposed ditch are invited to appear and be heard at said time.

A general description of the proposed starting point, route and terminus of said ditch, as stated in the petition or subsequently amended on the recommendation of the Engineer, is as follows, to-wit:

Commencing at the Southwest quarter of the Northwest quarter (SW $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section twenty-seven (27) thence in a southerly direction through the Northwest quarter of the Southwest quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$), Section twenty-seven (27), thence Southwesterly through the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$), Section twenty-eight (28), thence South through the East half of the East half (E $\frac{1}{2}$ of E $\frac{1}{2}$) of Section thirty-three (33), all in Township thirty-four (34), Range twenty-four (24), thence Southwesterly through the North half of the Northeast quarter (N $\frac{1}{2}$ of NE $\frac{1}{4}$), through the Northwest quarter (NW $\frac{1}{4}$), thence South through the West half of the Southwest quarter (W $\frac{1}{2}$ of SW $\frac{1}{4}$), Section four (4), thence in a westerly direction through the South half of the Southeast quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$), Section five (5), all in Township thirty-three (33), Range twenty-four (24) and the following branches:

Branch A, Commencing in the Southeast quarter of the Southwest quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section twenty-eight (28) thence southerly through the North half of the Northeast quarter (N $\frac{1}{2}$ of NE $\frac{1}{4}$), Section thirty-three (33), Township thirty-four (34), Range twenty-four (24) and connecting with the main ditch and

Branch B, Commencing in the Northwest quarter of the Southeast quarter (NW $\frac{1}{4}$ of SE $\frac{1}{4}$), Section Thirty-three (33), thence southerly and easterly through the South half of the Southeast quarter (S $\frac{1}{2}$ of SE $\frac{1}{4}$), Section thirty-three (33), Township Thirty-four (34), Range Twenty-four (24) and connecting with the main ditch and

Branch C, Commencing in the Southwest quarter of the Southeast quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$), Section thirty-three (33) and running through the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$), Section thirty-three (33), Township Thirty-four (34), Range Twenty-four (24) and connecting with the main ditch and

Branch D, Commencing in the Northwest quarter of the Northeast quarter (NW $\frac{1}{4}$ of NE $\frac{1}{4}$), Section Four (4) and running through the Northeast quarter of the Northeast quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$),

Section Four (4), Township Thirty-three (33), Range Twenty-four (24) and connecting with the main ditch and

Branch E, Commencing in the Southeast quarter of the Northeast quarter (SE $\frac{1}{4}$ of NE $\frac{1}{4}$), Section Four (4), thence running in a northwesterly direction through the Northeast quarter of the Northeast quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), Section Four (4), Township Thirty-three (33), Range Twenty-four (24) and connecting with the main ditch and

Branch F, Commencing in the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$), Section Five (5), Township Thirty-three (33), Range Twenty-four (24), thence northerly and connecting with the main ditch said Ditch No. 18 terminating at the Rum River as its outlet.
