of Minnesota, praying for the establishment and construction of a public Ditch

along the following described route: commencing in N.E. 1/4 of Sec. 26 Town 34 Range 24 thence westerly into Vollerst Lake (so called) in N.W. 1/4 of Sec. 26 said Town and Range; thence southerly through S.W. 1/4 of said sec. 26; thence southerly thro' sec 25 said Town & Range through sections 12 & 11 in T. 33 R. 24 to Grack Lake (so called) in said sec. 11; thro' sec. 15 and N.W. 1/4 Sec. 22 and E. 1/2 of sec. 21 and S.W. 1/4 sec. 21; thence southerly thro' sec. 20 & 17; thence southwesterly thro' N.E. 1/4 of sec. 20 said Town & Range and terminating in River as its outlet; also a branch commencing in the N.W. 1/4 of sec. 27 Town 33 Range 24 thence westerly thro' N.E. 1/4 of sec. 28 said Town and Range; thence southerly thro' S.W. 1/4 Sec. 21 to Main Ditch (in said sec. 21 as its outlet); also a branch commencing in the N.E. 1/4 of sec. 34 Town 34 Range 24; thence southerly & easterly thro' said sec. 34 & sec. 2 Town 33 Range 24 to Main Ditch in sec. 2 as its outlet.

shall pay all expenses, in case the Board of County Commissioners of said County shall fail to establish said proposed Ditch then the above obligation to be void, otherwise to remain in full force and virtue.
