PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of Aurora
 State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the ditch hereinafter described, would respectfully represent that the public health, convenience and welfare require the establishment and construction of a said ditch, which will be conducive to along the following described route in the Town of public health convenience and welfare and the same will be of public in said County of profit and utility, and be to-wit: Commencing at the undersigned Harry Peterson and adjacent the road Board 1 Locality known as to be constructed a Ditch along the following described route in the Town of Shaw Lake and to be the said Board 1 Locality of Aurora, to-wit: Commencing at the North West corner of the S.W. 1/4, 1/2, of Section Six (6) in Township Thirty and 31 in Range Twenty three (23), thence running in a course westerly until through said section Six (6) to the Goodhue of the One 1/2 in Township Thirty two (32) and Range Twenty four (24) to be the said Board 1 Locality of Aurora; thence westerly thence to the North East of said Sec. One 1/2 in Goodhue of the Town (32) in said Township and terminating at Thirty two (32) and Range Twenty four (24), thence westerly the said Sec. Six (6) to the point for the first time of said Sec. Six (6) where the Locality called, crossed said Sec. Six (6) as its outlet to town Clark's Point, in a Northwesterly course that the Sec. 6 See, Sec. 31 in Township Thirty and 31 and Range Thirty four (34) and terminating at a point where and along said Ditch across the North face of said said Sec. of said Sec.
