



Notice is hereby given, that, on the 3rd of May 1894, at 11 o'clock, a. m. at the County Auditor's Office in the City of Anoka, County of Anoka and State of Minnesota, I will sell jobs of ditching and ditching the Ditch No. 22 of Anoka County, including the Ditch No. 22 of Anoka County, by their order bearing date May 3rd 1894, viz: "In sections of 160 feet each of said sections to be known and numbered by stakes as shown by the map of the years in said matter, commencing at the one including the outlet, and from there successively, up stream to the one including the source, commencing at the north east corner of the north west quarter of the south east quarter of Section two and Range twenty-two (22) in Township thirty-two and Range twenty-two (22), thence southerly across said section number thirty-two (32) to section number five (5) in Township thirty-two (32) and Range twenty-two (22), thence southerly and westerly across said section five (5) to section six (6) in said town and range, thence westerly and southerly across said section six (6) to section seven (7) in said town and range, thence southerly across said section seven (7) and its interest the County Ditch running across said sections seven (7) and known as Ditch No. 22, and there terminating at its outlet, to the lowest responsible bidder or bidders, said work to be completed within the time required, and in the manner specified in said order, and above and no bid. will be entertained which exceeds the estimated cost of the construction, in any case, as stated in the said order; and the successful bidder will be required to give a satisfactory bond, with two freehold securities for the faithful performance and fulfillment of his contract, and to pay all damages that may accrue by reason of his failure to complete the job within the time required in the contract, the said order and estimates and profile are on file, and may be seen at my office.
