PRINTER'S AFFIDAVIT.

Came personally before me Granville S. Pease, and being duly sworn deposes and says, that he now is and during all the time hereinafter mentioned has been the publisher and printer of the Anoka County UNION, a weekly newspaper printed and published in Anoka, in said Anoka County, on Wednesday of each week. That he knows of his own knowledge that

Notice is hereby given, That, on the 9th day of March, 1895, at 11 o'clock a. m., at the County Auditor's office in the City of Anoka, County of Anoka and State of Minnesota, I will sell the jobs of digging and constructing the Ditch No. 23 of Anoka County, established by the Board of County Commissioners of Anoka County, State of Minnesota, by the order bearing date January 9th, 1895, viz: In sections of 100 feet each, each of said sections to be known and numbered by stakes, as shown by the report of the viewers in said matter, commencing at the one including the outlet, and from thence, successively, up stream to the one including the source. Commencing at or near the center of the $se\frac{1}{4}$ of $ne\frac{1}{4}$ of Section 1, Town 31, Range 24, thence northeasterly through the $ne\frac{1}{4}$ of said Section 1, to the $se\frac{1}{4}$ of Section 30, Town 32, Range 24, thence northeasterly through the $se\frac{1}{4}$ of said Section 30, into Section 31, Town 32, Range 23, thence in a northerly course through the West half of said Section 31, into the $sw\frac{1}{4}$ of $sw\frac{1}{4}$ of Section 30, Town 32, Range 23, and terminating at a point in Coon Creek (so called) in the $sw\frac{1}{4}$ of $sw\frac{1}{4}$ of said Section 30, 40 rods East of the West line of said $sw\frac{1}{4}$ of $sw\frac{1}{4}$ of said Section 30, to the lowest responsible bidder or bidders, said work to be completed within the time required, and in the manner specified, in said viewer's report. And no bid will be entertained which exceeds more than thirty (30) per cent over and above the estimated cost of the construction, in any case, as stated in the said order; and the successful bidder will be required to give a satisfactory bond, with two freehold securities, for the faithful performance and fulfillment of his contract, and to pay all damages that may accrue by reason of his failure to complete the job within the time required in the contract. The said order and estimates and profile are on file, and may be seen at my office.

the printed notice of Sale of Ditching Jobs hereto attached, cut from the columns of said newspaper, was inserted, printed and published in said newspaper once in each week for three successive weeks, and that all said publications were made in the English language.
