## PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of Shuika State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Ditch

hereinafter described, would respectfully represent that ~~the public health, convenience and welfare~~ require the establishment and construction of a ditch with a drainage of the public along the following described route in the Town of Leith, convenience and welfare, and the same will be of public use in said County of Shuika and will, and to-wit: Commencing at the undesignated ferry bottom next nearest the said Board of County Commissioners & cause to be estimated a ditch along the following described route in the Town of Leith, & wct.:  
Commencing at or near the center of the 26th North Section 1, Town 21 Range 24 Town Northwest, through the NW 1/4 and Section 1, to the NW 1/4 of Section 36 Town 22 Range 24 Town Northwest through the NW 1/4 of said Section 36 and Section 31 Town 22, Range 23, thence in a Northw. course through the West 1/2 of said Section 31, and the NW 1/4 of Section 32, and terminating at a point in Brown Creek (so called) in the NW 1/4 NW 1/4 of said Section 30, to wit East of the West line of said NW 1/4 NW 1/4 of said Section 30.  
as its outlet
