in said County commencing at a near the southeast
corner of the North East Quarter Section 14, Town 31
Range 23. Thence running southerly and through
any part of sections 14, 13, 6, 3, 24, 26 & 25 that may be
necessary and terminating in what is known as
Sandy or Golden Lake in R12 in Section 25, Towns 31
Range 23 in the northern part of said Lake also
near the south east corner of said R12 east outlet
