Whereas, A petition bearing date the 3<sup>rd</sup> day of November  
1897, signed by L. J. Anderson

praying for the establishment of a certain Ditch in said County, the  
route of which is more fully described in said petition, and a proper bond accompanying the same,

And Whereas, It appears, by satisfactory proof to the Board of County Commissioners of  
Anoka County, that at least thirty (30) days' notice of the pendency

And Whereas, Said Board has determined that the construction of such ditch as proposed  
in said petition will be of public benefit and utility, and conducive to the public health, convenience  
and welfare;

Now, Therefore, We, the Board of County Commissioners of said County, at a  
Regular session held this day, do hereby accept said petition, do  
hereby appoint John Hunter, Groton's Findings and J. A. H. Johnson

three resident freeholders of said County, and not interested in the construction of said proposed  
work, and not of kin to any parties interested therein, as viewers, and do specify the 15<sup>th</sup>  
day of Jan 1898, at County Auditor's Office in City of Anoka at One o'clock P.M. as the time and place for said viewers to meet,  
preparatory to commencing their duties as such viewers, as prescribed by law, and after completing  
their duties as such viewers to make and file their report with the County Auditor of said County,  
on or before the 15<sup>th</sup> day of March 1898.
