At the said meeting at the time and place aforesaid the said Board of County Commissioners did proceed to hear and consider said petition and the matter of establishing and constructing said ditch, and all things pertaining thereto, and did hear all parties interested therein, both for and against the same; and, having duly considered the same, find as follows, to wit:

FIRST: That notice of the hearing above referred to on said petition, and on said engineer's report and on said viewers' report thereon, and upon the establishment and construction of said ditch has been duly given, published, posted, and mailed, as by law required, and that proof of the service, publishing, posting, and mailing of said notice has been duly made and filed in the office of the County Auditor of said county.

SECOND. That said civil engineer has completed his work of the survey of said ditch, and filed the same in the office of the county auditor of said county, and that said report is in all respects complete and correct and according to law.

THIRD. That said viewers have duly viewed said ditch and completed their work of the same and duly filed their report thereon in the office of the county auditor of said county, and that said report is in all respects complete and correct and according to law.

FOURTH. That the benefits estimated to be derived from the construction of said ditch are greater than the total cost of the same, including the damages estimated and awarded on account thereof.

FIFTH. That the benefits and damages arising from the construction of said ditch have been duly assessed and awarded.

SIXTH. That the establishment and construction of said ditch will be of public utility and will promote the public health, and is necessary because it will promote the public health and will benefit the lands adjacent thereto and is necessary for the following reasons, among others, to-wit: The lands to bedrained by the proposed ditch and its branches consist largely of low meadow, marsh and swamp land surrounded and interspersed by large areas of valuable cultivated lands; the low land is cold, wet and scmetimes overflowed, rendering it largely valueless in its present condition; that when properly drained it will greatly enhance its value; that there are several roads passing over and along said wet lands that will be greatly benefited
