YOU, AND EACH OF YOU, WILL PLEASE TAKE NOTICE, that the State of Minnesota, by James C. Marshall, its Commissioner of Highways, has filed a Petition with the County Auditor of Anoka County, pursuant to Section 161.28 of Minnesota Statutes 1959, praying that he be allowed to make a minor alteration or change in County Ditch No. 28. That attached to said Petition now on file with the County Auditor are plan and profile sheets showing said minor alteration or change petitioned for. That the portion of said County Ditch No. 28 as now located which is proposed to be changed or altered is described as follows:

Approximate Present Location of Portion of County Ditch No. 28:

From a point on the north line of section 32, township 33 north, range 23 west, distant 129.3 feet east of the north quarter corner thereof, run southerly at an angle of 86°36' with said north section line (when measured from east to south) for a distance of 108.2 feet; thence deflect to the left at an angle of 1°56′15' and run southerly for a distance of 600 feet; thence deflect to the left at an angle of 38°30' and run southeasterly for a distance of 220 feet to the point of beginning of the line to be described; thence run northeasterly on the last described course for a distance of 350 feet; thence deflect to the right at an angle of 36°00' and run northerly and parallel to Trunk Highway No. 65 in place for a distance of 3115.0 feet and there terminating.
