PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of Douglas State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Ditch hereinafter described, would respectfully represent that the public health, convenience and welfare require the establishment and construction of said Ditch will be conducive to along the following described route in the Town of the public health convenience & welfare public benefit & utility and that the construction of the same would be of public benefit and utility the undersigned hereby petition & request the

A general description of the proposed starting point, route and terminus of said ditch is as follows—

Commencing at said Board of County Commissioners to course to be constructed a Ditch along the following described route, in the Town of Douglas, to-wit: South of Douglas, to-wit: South-west corner of the Block West quarter of the North-East quarter Sec 27 of N 21 & Section 16 in Township 16 N in Range 16 E in County of Douglas, then (28) through corners in a North-Southly course through said Section 16 to the East line of Sec One (1) in Township of Douglas then (32) and Range of Douglas, then (24) in East half of of Douglas, thence westerly through the North-half of said Sec One (1) to and East line of Sec 2 in said Township of Douglas, then (32) and Range of Douglas, then (24) thence South westerly through said Sec One (1) to point on the West line of said Sec (2) where to cross North-Southly called course and Sec line through the South-East quarter of Sec One (1) in Township of Douglas, then (32) and Range of Douglas, then (24) and terminating at the point where said North-East quarter crosses the North line of the said South-East quarter of Sec One (1) and Sec One (1) as aforesaid will then proceed West as aforesaid and the Ditchers may claim necessary to give the land adjacent to the construction of said Ditch the full benefit thereof.
