AUDITOR'S NOTICE OF PENDENCY OF
Petition, State of Minnesota, County of

Anoka, ss.
Whereas, the clerks appointed by the Board of County Commissioners of said county of Anoka, at their session held on the 12th day of March, 1898, upon the petition of James McDonald, Andrew Mattson, John H. McDermid and others, bearing date the 24th day of January, 1898, and on the 23rd day of February, 1898, and on the 11th day of July, 1898, in said county, on the 11th day of July, 1898, at 10 o'clock a. m.

Now, therefore, notice is hereby given of the pendency of said petition and that the same will be heard and determined before the said Board of County Commissioners, at their session to be held at Court House in the city of Anoka, in said county, on the 11th day of July, 1898, at 10 o'clock a. m.

The place of commencement of said ditch at its source is as follows: Commencing about thirty (30) rods east of the center of the n.w. 1/4 of section 1, town 38, range 25; thence in a general northwesterly direction through the n.w. 1/4 of said section 1 and the s.w. 1/4 of section 38, town 34, range 25, and the s.w. 1/4 of section 38, said town 34, range 25, to Seale's Brook (so-called), at its outlet.

Also a branch commencing about 10 rods east of the ne corner of the n.w. 1/4 of section 2, town 38, range 25; thence southeasterly about 40 rods, thence northeasterly through n.e. 1/4, s.e. 1/4, section 2, town 38, range 25 and s.w. 1/4 of section 35, town 34, range 25, to main ditch.
