## PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of Jordan.

State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Public Ditch.

hereinafter described, would respectfully represent that the public health, convenience and welfare require the establishment and construction of a Public Ditch, commensurate to along the following described route in the Town of the Public Health, commences at Wells St. Conway will be in said County of public benefit reliably and will be undertaken hereby for the benefit and request the Board of County Commissioners to cause to be constructed a Ditch along the following described route in the Town of Columbus, said County of Wells St. Conway as follows:

commencing at about the middle of Sec. 1 Town 32 Range 22, hence running in a general northerly direction thru Sec. 10 Sec. 11 Sec. 12 Sec. 13 Sec. 14 Sec. 15 Sec. 16 Sec. 17 Sec. 18 Sec. 19 Sec. 20 Sec. 21 Sec. 22 to terminus in Spring Creek (so called) at or near the Town line.

Also commencing at the starting point of Ditch in Sec. 1 Town 32 Range 22, hence running in a general southerly direction through Sections 1-12 - 11<sup>th</sup> 1<sup>st</sup> terminus being in Spring Creek so called in Sec. 14 Town 32 Range 22.

Also Branch Ditch beginning in the middle of Sec. 1 Town 32 Range 22, commencing in Branch Webster Branch Sections 1-2 - 1<sup>st</sup> 1<sup>4</sup> and terminating in Huron Lake in Sec. 14 said Town of Range 22, with such other branches as the owners may deem necessary to give the lands affected for the construction of said Ditch, the full benefit thereto.
