PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of _____ State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Public Ditch hereinafter described,

would respectfully represent that the public health, convenience and welfare require the establish-

ment and construction of a Public Ditch which will be conducive to the following: ~~the~~ ^{the} public health, convenience and welfare and the same will be of public benefit and utility, and that the construction of the same would be of public benefit and utility.

A general description of the proposed starting point, route and terminus of said ditch is as follows:

Commencing at about the middle of Dec 1 Town 32 Range 22, thence running in a general northern direction through sections 26 and 25 Town 33 Range 22 to terminating in Township 34 (so called) at or near the Town line. Also commencing at the starting point of Ditch in Sec. 1 Town 32 Range 22, thence running in a general southerly direction through sections 1-12 and 11 and terminating in Township 34 (so called) in Sec 14 Town 32 Range 22.

Also a Branch Ditch beginning in the middle of Sec 1 Town 32 Range 22, thence running South & easterly through sections 1-2-11 and 14 terminating in Township 34 (so called) in Sec 14 and Range 22. It will cross other branches on the western side of necessary to give the land access for the construction of said Ditch, the full benefit thereof.
