along the following described route: Commencing about the middle of Sec 1 Town 32 Range 22, thence running in a general Northerly direction through Sections 36, 37, 38 Town 33 Range 22 to Section 11 in Township 36th as called, at or near the town line also thence running in a general Southerly direction through Sections 1-12 11 and 14 terminating in Howard Lake as called in Sec 14 Town 32 R. 22 also a Branch ditch beginning in the middle of Sec 10 T. 32 R. 22 thence running South-Westerly through Secs 15-115 14th terminating in Howard Lake in Sec 14 and down by Road 65 with such other branches as the signers may deem necessary to give the lands owned for the construction of said ditch, the full benefit thereon whenever Now of the said Harv Hanson, Andrew Hanson and G.
