Balance Under for

At a meeting of the Board of County Commissioners held Nov. 25, 1909, it was voted to transfer the repair account to the ditch fund, there being a sufficient balance in that fund to the credit of County Ditch No. 32, the expense of the repairs to be paid from this account under the provisions of Chapter 469 of laws of 1909, and no further proceedings for assessment be taken.
