NOTICE OF APPEAL of DANIEL PEEBLES.

NOTICE IS HEREBY GIVEN, That Daniel Peebles, who is the owner ~~in~~ and entitled to the possession of the following described lands and premises in Anoka County, Minnesota, to-wit: -

The Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section Seven (7), in Township Thirty-one (31) and Range Twenty-two (22); The Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4), and the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4), and the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4), of Section One (1), in Township Thirty-one (31) and Range Twenty-three (23), and the Southeast Quarter (SE 1/4) of the Northwest Quarter (NW 1/4) of Section Thirteen (13), ~~in~~ in Township Thirty-one (31) and Range Twenty-three (23); deeming himself aggrieved and being in fact aggrieved by the order of the County Board of Anoka County, Minnesota, made and dated on the 26th day of October, A.D. 1915, and filed in the office of the Auditor of said County, in and by the terms of which said order the amount of benefits and damages to the above described tracts of land and each of them on account of the Repair of County Ditch No. 32 of Anoka County, Minnesota, was fixed and determined as follows, to-wit: -

Northwest Quarter (NW 1/4) of Southeast Quarter (SE 1/4) of Section Seven (7), in Township Thirty-one (31) and Range Twenty-two (22), amount of damages allowed, none, amount of benefits assessed, \$700.00;

Southeast Quarter (SE 1/4) of Northeast Quarter (NE 1/4) of Section One (1), in Township Thirty-one (31) and Range Twenty-three (23), amount of damages allowed, none, amount of benefits assessed, \$170.00;

Northeast Quarter (NE 1/4) of Southeast Quarter (SE 1/4) of said Section One (1), amount of damages allowed, none, amount of benefits assessed, \$70.00;

Southeast Quarter (SE 1/4) of Southeast Quarter (SE 1/4) of said Section One (1), amount of damages allowed, none, amount of benefits assessed, \$50.00;

Southeast Quarter (SE 1/4) of Northwest Quarter (NW 1/4) of Section Thirteen (13), in Township Thirty-one (31), Range Twenty-three (23), amount of damages allowed, none, amount of benefits assessed, \$180.00;

All by reason of the repair of said ditch; Hereby appeals from said order fixing and determining said amount of assessed benefits as aforesaid and as in said order described, as to each and every of said tracts and premises, on account of the repair of said ditch, and hereby demands a jury trial to determine the amount of benefits to said lands and premises and each tract thereof, on account of the repair of said ditch, and that said appeal is taken to the District Court in and for the County of Anoka and State of Minnesota, according to the statute in such case made and provided. Said Daniel Peebles further states that such appeal and demand as made as aforesaid on the grounds and for the reason that the estimated and assessed benefits as aforesaid, to be derived from the repair of said ditch, as to each and every of said tracts, are greater than the actual benefits to be derived from the repair of said ditch.
