Came personally before me Granville S. Pease, and being duly sworn deposes and says, that he now is and during all the time hereinafter mentioned has been the publisher and printer of the Anoka County UNION, a weekly newspaper printed and published in Anoka, in said Anoka County, on Wednesday

AUDITOR'S NOTICE OF PENDENCY OF Petition.
State of Minnesota, County of Anoka—ss.
Whereas, the viewers appointed by the Board of County Commissioners of said County of Anoka at their session held on the 29th day of June, 1898, upon the petition of John B. Houle, Jos. P. Peltier, J. H. Sherman, Cyrille Bernier and others, bearing date the 30th day of April, 1898, and on file in my office, praying for the establishment of a public ditch along the route proposed therein, have made their report and filed the same in my office.
Now, therefore, notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their special session to be held at the court house in the City of Anoka in said county, on the 14th day of October, 1898, at 10 o'clock a. m.
The place of commencement of said ditch at its source is as follows:
Main line beginning on N. line of se¹/₄ of se¹/₄, Sec. 12, T. 31, R. 22, thence southerly through said se¹/₄ of se¹/₄ and ne¹/₄ of Sec. 13; thence westerly and S. westerly through nw¹/₄ of se¹/₄, e¹/₂ of sw¹/₄ and sw¹/₄ of sw¹/₄, Sec. 13; w¹/₂ of nw¹/₄, Sec. 24 and se¹/₄ of ne¹/₄, Sec. 23 and terminating in Clear Water creek in se¹/₄ of ne¹/₄, Sec. 23, all in T. 31, R. 22.
Branch No. 1 com. in w. pt. ne¹/₄ of sw¹/₄, Sec. 13, T. 31, R. 22, thence easterly through said ne¹/₄ of sw¹/₄ to main line of ditch and there terminating.
Branch No. 2 com. on S. line of se¹/₄ of se¹/₄, Sec. 13, T. 31, R. 22, thence runs west on section line about 70 rods; thence northerly and westerly through sw¹/₄ of se¹/₄ and on the line between ne¹/₄ of sw¹/₄ and se¹/₄ of sw¹/₄, said Sec. 13, about 40 rods to main ditch and there terminating.

That he knows of his own knowledge that the printed notice of Auditor's Notice of Pendency of Petition hereto attached, cut from the columns of said newspaper, was inserted, printed and published in said newspaper once in each week for three successive weeks, and that all said publications were made in the English language.
