WHEREAS, The viewers appointed by the Board of County Commissioners of said County of Anoka at their session held on the 21<sup>st</sup> day of Dec. 1898, upon the petition of M. St. P. Starns & Co., Mrs. Mary E. Day, Henry Brunk and others, bearing date the 15<sup>th</sup> day of September 1898, and on file in my office, praying for the establishment of a public ditch along the route proposed therein, have made their report and filed the same in my office.

Now, therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their regular session to be held at the Court House in the City of Anoka in said County, on the 15<sup>th</sup> day of

August—1899, at 10 o'clock P. M.

The place of commencement of said ditch at its source is as follows: Commencing at Section line, between Sections Three (3) in Town of Spring and Sec. Thirty four (34) in Town of Oak Grove in Clark's Brook had called where the said Brook crosses said Section line thence to follow said Brook and clearing the same in said Sec. 24, 29, 33 & 34 to Cedar Creek in said Sec. 24 and thence to terminate.
