PETITION FOR PUBLIC DITCH.

To the Board of County Commissioners of the County of Anoka State of Minnesota:

The undersigned land owners, whose lands will be liable to be affected by, or assessed for, the expense of the construction of the Public Ditch hereinafter described, would respectfully represent that the public health, convenience and welfare require the establishment and construction of a Public Ditch along the following described route in the Town of Cake Grove in said County of Anoka and that the construction of the same would be of public benefit and utility.

A general description of the proposed starting point, route and terminus of said ditch is as follows
Commencing at Section line between sections three (3) mi
son of Grove and Sec. thirty four (34) mi town of Cake Grove
in Belknap's Brook (so called) where the said Brook crosses
said Section line thence to follow said Brook and clearing
the same in said Sec. 34 T. 33 R. 24. to Cedar Creek in said
