July 1899 upon the petition of Gust Gust, A. Hoffmann

Aug. Landen, John Gust, Andrew Mjond others, bearing date the 2^d day of November 1898, and on file in my office, praying for the establishment

of a public ditch along the route proposed therein, have made their report and filed the same in my office. Said ditch to be numbered 83.

From, therefore, Notice is hereby given of the pendency of said petition, and that the

same will be heard and determined before the said Board of County Commissioners, at their

regular session to be held at the Court House in the City of Anoka in said County, on the 15th day of

August 1899, at 10 o'clock A. M.

The place of commencement of said ditch at its source is as follows:

Comm at the S.W. cor. of Sec. No. 3 Twp. 32. R. 22. N. 2^d ranging in a north easterly direction through said Sec. No. 3 into land through Sec's No. 8 & 7, 95, and part of Sec. No. 26 terminating in County Ditch No. 12 at the center of said Sec. 26, all on S. 33 R. 22, and with such Branch or Branches, as the viewers may deem necessary to give the lands access for the construction of said ditch to full benefit thereof. Branch No. 1 beginning at the W. 1/2 part of Sec. 2 S. 32. R. 22. Th. running N. easterly of North, through said Sec. 2 and through Sec. 35 and part of Sec. 26. Terminating in Main Ditch, about the center of the South West quarter of said Sec. 26, all in Twp. 33, Range 22. Br. No. 2 beginning about the center of the NE 1/4 Sec. 10, running N. westerly through said quarter Sec. into Sec. 3, and terminating in Main Ditch about the center of the SW 1/4 of Sec. 3, R. 22. Br. No. 3 beginning near the center of the NE 1/4 of Sec. 32 R. 22 Th. running in a N. easterly direction and terminating in Main Ditch near the center of N 1/2 of NW 1/4 of Sec. 3. Twp. 32. R. 22.
