Whereas, The viewers appointed by the Board of County Commissioners of said County of Anoka at their session held on the 23<sup>rd</sup> day of Feb. 1899 upon the petition of John M. Starkey Jeff Starkey & D. Day M. R. Fowler and others, bearing date the 16

day of July 1898, and on file in my office, praying for the establishment of a public Ditch along the route proposed therein, have made their report and filed the same in my office. Said Ditch to be numbered 36.

Now, Therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their Regular session to be held at the Court-House in the City of Anoka in said County, on the 12<sup>th</sup> day of August 1899, at 11 o'clock A.M.

The place of commencement of said Ditch at its source is as follows: Main Ditch commencing at or near the N.E. corner of the North-West-quarter of the N.W. 1/4 of Sec. 20 Town No. 33 Range 23.1 and running in a generally southerly ~~direction~~ direction through the West one half (1/2) of said Sec. 20 and the N.W. 1/4 of Sec. 29- of said Town & Range. Branch No. 1. Com. on the South-line of the N.W. 1/4 of N.E. 1/4 of Sec. 20. Branch No. 2. on the quarter-sec. line in the S.E. 1/4 of Sec. 20. Branch No. 3. on the S. line of S. 1/2 of Sec. 20 all in Twp. 33. Range 23.1 & head at lower than 1897
