Whereas, The viewers appointed by the Board of County Commissioners of said County of Anoka at their session held on the 2<sup>d</sup> instant, day of Feb., 1899, upon the petition of John M. Stucky, Jeff Stucky, Mr. D. Day, M. R. Fowler and others, bearing date the 16th day of July, 1898, and on file in my office, praying for the establishment of a public Ditch along the route proposed therein have made their report and filed the same in my office. Said Ditch to be named and numbered 36.

Now, Therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their Regular session to be held at the Court-House in the City of Anoka, in said County, on the 12<sup>d</sup> day of August, 1899, at 11 o'clock A.M.

The place of commencement of said Main Ditch, commencing at or near the NE corner of the North-West quarter of the 1/4 sec. 10, Town No. 89 Robins L3 and running for a generally southerly direction through the West one half of said sec. 10 and the N 1/4 sec. 9 - said Town & Range Branch No. 1. from on the south line of the 1/4 sec. 10 to the quarter sec. line in the Branch No. 2 on the S line of 1/2 of sec. 10 all in Township 89, Range 29, of Kandiyohi Co., Minn.
