Whereas, A petition bearing date the 1st day of July 1898, signed by John M. Parkley, J. P. Parkley, John O. Ray, M. Peterson, W. M. Allen, Frank Gardner and Oscar Butler praying for the establishment of a certain Ditch in said County, the route of which is more fully described in said petition, and a proper bond accompanying the same, have been filed with the County Auditor of said County, as by law required;
