YOU, AND EACH OF YOU, WILL PLEASE TAKE NOTICE, THAT the State of Minnesota, by James C. Marshall, its Commissioner of Highways, has filed a Petition with the County Auditor of Anoka County, pursuant to Section 161.28 of Minnesota Statutes 1959, praying that he be allowed to make a minor alteration or change in County Ditch No. 36. That attached to said Petition now on file with the County Auditor are plan and profile sheets showing said minor alteration or change petitioned for. That the portion of said County Ditch No. 36 as now located which is proposed to be changed or altered is described as follows:

Approximate Present Location of a Portion of County Ditch No. 36:

From a point on the east and west quarter line of section 29, township 33 north, range 23 west, distant 43 feet west of the center of said section 29, run southerly at an angle of 88°30' with said east and west quarter line for a distance of 145 feet to the point of beginning of the line to be described; thence run northerly on the last described course and parallel to old trunk highway in place for a distance of 3390.0 feet; thence deflect to the left at an angle of 21°30' and run northwesterly for a distance of 205 feet; thence deflect to the right at an angle of 21°30' and run northy for a distance of 80 feet; thence deflect to the right at an angle of 80°00' and run northeasterly for a distance of 110 feet; thence deflect to the left at an angle of 26°00' and run northwesterly for a distance of 110 feet; thence deflect to the left at an angle of 36°00' and run northwesterly for a distance of 400 feet; thence deflect to the left at an angle of 65°00' and run northwesterly for a distance of 400 feet; thence deflect to the left at an angle of 45°30' and run northwesterly for a distance of 400 feet; thence deflect to the left at an angle of 45°30' and run northwesterly for a distance of 400 feet; thence deflect to the left at an angle of 45°30' and run northwesterly for a distance of 65 feet and there terminating.
