Whereas, The viewers appointed by the Board of County Commissioners of said County of Anoka at their session held on the 10<sup>th</sup> day of July 1899, upon the petition of E. J. Rogers Anton Larson and others, bearing date the 9<sup>th</sup> day of June 1899, and on file in my office, praying for the establishment of a public Ditch along the route proposed therein, have made their report and filed the same in my office.

Now, therefore, Notice is hereby given of the pendency of said petition, and that the same will be heard and determined before the said Board of County Commissioners, at their Special session to be held at South Lake in the City of Anoka in said County, on the 14<sup>th</sup> day of February 1900, at 2 o'clock P. M.

The place of commencement of said Ditch at its source is as follows: Commencing at about the center of the N<sup>o</sup> 1/4 of the S<sup>o</sup> 1/4 of section 14, thence in a westerly direction 80 rods, thence southeasterly to the south line of section 14 thence nearly west along the section to the East line of the N<sup>o</sup> 1/4 of N<sup>o</sup> 1/4 of section 21 thence south about 80 rods thence west 80 rods thence in a southerly direction to the south line of section 21 thence in a southeasterly direction to intersect an old ditch, thence following the old ditch to Boom Creek
