The undersigned, County Commissioners of the County of Anoka in the State of Minnesota do hereby certify to the County Auditor of said Anoka County, that said Board, pursuant to notice duly mailed, given, published and posted, proof whereof is duly filed herein, did duly meet at the office of the County Auditor of said Anoka County at the Court House in the City of Anoka, on Wednesday, the 16th day of February, 1910, at 10.30 o'clock A'M' of said day, and did then and there consider the matter of the repairs etc on said County Ditch, and the assessments of benefits therefor, and did duly hear all parties interested therein, and did then and there assess the cost of such repairs etc upon the lands benefitted thereby, as by law provided:-

That the cost of the repairs etc on said Ditch No. 4 as found and computed by said Board is the sum of \$498.93

That to reimburse the revenue fund of said County for the cost thereof, the said cost thereof is hereby apportioned and assessed upon the following described lands and premises situated in Anoka County, State of Minnesota, in the following respective amounts upon and against the following respective described tract lots and parcels of land, to-wit:-
