Gentlemen:

I have made an inspection of County Ditch No. 41 from Trunk
Highway No. 65 to County Aid Road No. 48 (University Avenue Extension).
I found more water in said ditch between Trunk Highway 65 and 117th Street
than there was west of 117th Street at highwater stage. Therefore, I
walked along the ditch west to University Avenue and found several blocks
in said ditch along this stretch, caved in slopes, growth, and other obstructions. After checking the ditch records, I find a very flat grade
from 117th Street to University Avenue, but from University Avenue west
a good fast grade.

I therefore recommend that the obstructions be removed in Ditch No. 41 from 117th Street to University Avenue. In my opinion this would greatly improve the run-off from the area east of Trunk Highway 65 and would enable said ditch to perform the functions for which it was originally constructed; also that said work be done by force account at a cost not to exceed \$500.00 and be paid for under the authority granted the Board under Minnesota Statutes Chapter 106.471.

I further recommend to the Board that the Village of Blaine be ordered to remove any and all blocks caused by material washing into said ditch from the road shoulders over and across the section where 117th Street runs parallel and is adjacent to Ditch No. 41 under authority granted by Minnesota Statutes Chapter 106,491

That the County Auditor be, and hereby is, ordered to make and levy such assessments and to file in the office of the Register of Deeds of said county a summary statement and lien thereof against all lands benefited in the original proceeding for the construction of said system in the same proportionate amounts or as may be amended by construction of said system in the same proportionate amounts or as may be amended by the Highway Engineer; said summary statement to be as by law required in case of the original construction of said system.
