I will sell the jobs of digging and constructing the Ditch No. 41 of Butte County, established by the Board of County Commissioners of Butte County, Minnesota, 1904, viz.:

to the lowest responsible bidder or bidders, said work to be completed within the time required, and in the manner specified, in said Surveyor's report. And no bid will be entertained which exceeds more than thirty (30) per cent over and above the estimated cost of the construction, in any case, as stated in the said order; and the successful bidder will be required to give a satisfactory bond, with two freehold securities, for the faithful performance and fulfillment of his contract, and to pay all damages that may accrue by reason of his failure to complete the job within the time required in the contract. All bids must be accompanied by a certified check for a fee to the Auditor of said County for services herein provided.
