Notice of Hearing on Petition for Repair of Ditch

State of Minnesota, County of Anoka ss. In the Matter of the Petition of A. Mathshak and Others for the Repair of County Ditch No. 41, County of Anoka.

Whereas, The engineer heretofore appointed by the County Board of Anoka County to ascertain and report the cost of repairing County Ditch No. 41 in Anoka County has made and filed his report, and the viewers appointed by the Board have filed their report, and Whereas, The said County Board have, by their order made and filed herein, appointed a time and place when and where they will hear and determine the said petition and report.

Now Therefore, Notice is Hereby Given, That the County Board of Anoka County will meet at the Office of the County Auditor of said County on the 10th day of August 1917, at 2 o'clock p. m., for the purpose of determining the necessity for the repair of said ditch and to apportion and assess the cost thereof, at which time and place all persons interested are required to appear and show cause, if any there be, why such repairs should not be made, and the cost thereof apportioned and assessed to the lands benefited thereby, as by law required.
