I, the undersigned engineer appointed to survey and inspect and oversee the construction of Ditch No. 43 in your County, hereby report that I have inspected the digging and construction of the sections of said Ditch, numbered as follows:

F. Doyle for said amount; and I certify that no loss will result to said County by the payment of the above amount on account of said work so performed.
