

AUDITOR'S NOTICE OF HEARING AFTER VIEWERS' REPORT IN DITCH PROCEEDINGS

In the matter of the petition of Hudson Guy and others for a public ditch in the County of Anoka, State of Minnesota:

NOTICE IS HEREBY GIVEN, That, whereas, a petition has been filed in the office of the County Auditor of said County, praying for the establishment and construction of the ditch herein referred to, and the civil engineer appointed by the Board of County Commissioners of said County to make a survey of the route of said ditch has completed his work and made due report thereof and filed said report in the office of the County Auditor of said County, and the viewers appointed by said Board of County Commissioners to view the same have completed their work and filed their report thereof in the office of said County Auditor; which ditch as specified and laid out in said petition, said report of said engineer, and the report of said viewers, commences at Station 0, whence 1/8 section post, center of the N.E.1/4 Sec. 36, T.33, R.24, bears west 138 feet, as its source, and runs thence along the following route, to-wit: westerly and northerly through N.E.1/4 of the N.E.1/4 of Sec. 36, N.W. 1/4 of N.E. 1/4, Sec. 36, S.W. 1/4 of S.E.1/4 of Sec. 25, Lot 2 Sec. 25, and northerly through Swan Lake to Lot 6 Sec. 25, thence northerly through said Lot 6 and westerly through the W.W.1/4 of the N.W.1/4 Sec. 25, and the N.E.1/4 of the N.E.1/4 Sec. 26 to railroad right of way: thence on and along said right of way to culvert in the S.W.1/4 of S.W.1/4 Sec. 24, thence westerly through culvert and northerly through the S.E.1/4 of the S.E.1/4 of Sec. 23, to Cedar Creek in the N.E. portion of said S.E.1/4 of the S.E.1/4 of Sec.23, all in Town 33, Range 24, and terminating in said Cedar Creek as its outlet: and has certain proposed branches the description, sources and termini of which are as follows, to-wit: Branch No.1, commencing at Station 0, Branch No. 1 in the east and west road on the north line of the M.C.Pontius property near the center of the N.W.1/4 of N.W.1/4 Sec. 36, thence northerly through said N.W.1/4 of N.W.1/4 of Sec. 36, Lot 1 of Sec. 25, and Swan Lake, and ending in the main ditch at Station 46 + 85 in said Swan Lake: which said ditch and the said branches thereof, as appears from said report of said engineer pass through certain lands and affect certain roads, railroads, municipal corporations, and other corporations, the descriptions of which lands, roads, and railroads, and the names of the owners thereof and of the municipal and other corporations so affected thereby, are as follows, to-wit: Thomas Green, S.E.1/4 of S.E.1/4 and S.W.1/4 of S.E.1/4, Sec. 25, T.33, R.24; Walter Smith S.W.1/4 of S.W.1/4, Sec.30, T.33, R.23; G.
