TO THE BOARD OF COUNTY COMMISSIONERS OF ANOKA COUNTY.

I, the undersigned, engineer appointed by you to survey, inspect and oversee the construction of Ditch No. 48 in your county hereby report that I have inspected the digging and construction of the sections of said ditch as follows to-wit:-

From Section numbered Forty Nine (49) to Section Eighty Two (82), both inclusive.

Which said sections were sold to Mr. Miller and by him contracted to be constructed for the total sum of Five Hundred and Two and Ninty Nine Hundredths Dollars, (\$ 502.99). I find that the said Mr. Miller has performed work upon the sections herebefore named within the said County for the full value of Five Hundred and Two Dollars (\$ 502.00) in accordance with his said contract and the plans and specifications and report of the said Engineer, which said work is hereby approved be me; and that the said Mr. Miller is entitled to a partial payment on account of said work of Seventy Five per cent (75 %) of said work already done, being the sum of Three Hundred and Seventy Six and Fifty Hundredths Dollars (\$ 376.50) to be paid to him out of the General Ditch Fund of the said County according to Law upon the written approval of the County Auditor of the said County, of this certificate this day issued by me to the said Mr. Miller for the said amount. I hereby certify that no loss will result to the said County by the payment of the above amount on account of the said work so performed.
