In The Matter Of The Petition Of J. W. Merrill and others for a Public Ditch in the County of Anoka, State of Minnesota.

To the honorable Board of County Commissioners of the County of Anoka, State of Minnesota:

T, the undersigned civil enginerr appointed by your honorable body on the July 31st. 1907 to survey the proposed route as presented in the petition of J. W. Merrill, and others for a public ditch would respectfully report, that within the time specified in your said order, I did make a complete survey of the line of the proposed public ditch from its sourse to its outlet, and of the branches thereof, and did cause stakes to be set along said line, and along the branches thereof, numbered progressively down stream at each One Hundred Feet.

Thid also upon the written request of the petitiocers and their bondsmen, survey a line for a ditch from the Swn Lake, so-called, southerly
and westerly along the natural outlet of said lake, through the lands of
Wr. Thos Lee and Mr. Townsend to Cedar Creek; and set and mark stakes
progressively down stream from the lake to the entrance of the stream
therefrom into Cedar Creek on the Lands of Marry L. Sill.

That in making said survey I did locate the source, outlet, and line of the said rublic ditches and their branches, as near the points of source, outlet and line described in said petition therefor as practicable, and did consider and specify such branches of said Fublia Ditch as in my opinion are necessary to give the land owners likely to be assessed for its construction the full benifit thereof; and whereever the line of said ditch is along established highways I did locate it at a sufficient distance from the center of said highways to admit of good roads along the center line thereof, and in such a manner as to provide sufficient and suitable culverts and openings to drain away the surface water therefroo, and so as not to obstruct the flow of surface water therefroo in time of high water; and did, so far as practicable locate said Public Ditch on division lines, between owners lands owned by different persons, and did avoid, as far as practicable without sacrificing the general utility thereof, laying the line of said Public Ditch diagonally appears to the said Public Ditch diagonally as far as practicable without sacrificing the

across lands owned by persons on or across which the said Public Ditch must pass.

I have caused a map of said survey to be made, showing the line and location of said Public Ditch and Its Branches, the highways along which any part thereof runs, the stakes placed along the line thereof and along said branches thereof and the number of each stake, the seperate tracts of land over or across which any part thereof and its branches pass, a description of each tract, the number of acres in each tract, the boundaries of each tract, and the name of the owner of each tract, the location of the line of the Great Northern R.R., the location of the outlet of Swæn Lake. On the same map I have shown the two different ways of draining the territory covered by the petition, which said map of the whole part is hereto attached and made a part hereof, marked "Exhibit 1" of Ditch No. 48.

I did further cause to be made in tabular form a statement, showing the number of cubic yards to be excavated between each of the One Hundred foot stakes along the line of the said Public Ditch as petitioned and also of the route following the natural outlet of the Swan Lake, and of all the branche: of both routes, the cost of excavating the same per cubic yard, the estimated cost of the removal of obstructions between each of the said one hundred feet stakes, the estimated cost of all wood and masonary work, fences or bridges necessary between each if said one hundred feet stakes, the estimated coast of all underground work with tile or other material between each of the one hundred feet stakes, the total estimated number of cubic yards to be excavated from said public ditch and its branches, the estimated preliminary expenses and the expense of inspecting the same until its completion, and the total estimated cost of said work complete to its completion; which tabular statement is hereto attached and made a part hereof, marked "Exhibit 2."

I did further cause to be specified and set forth in tabular form the depth of cut, the width at the bottom, the width at the top, between each one hundred feet stake of said Public Ditch and its branches, the obstructions to be removed, the wood or masonary work, fences, bridges or other struc-

tures, necessary to be constructed between each of the said One Hundred feet stakes, the underground work, with size and character of tile and other material necessary to be constructed between each of said One hundred feet stakes, the manner in which the several kinds of work is to be done, and the time within which the owrk on each of said sections between said one hundred feet stakes is to be done; which tabular statement is attached hereto and made a part hereof, marked "Exhibit 3"

I did further cause to be specified and set forth in tabular statement, showing the time occupied by me in making said survey and my compensation therefor; the names of the assistants and laborers employed in making said survey, the time each was employed, the amount per day of each and their compensation, and the total amount each is to be , aid; and the other expenses of every kind and nature incurred by me in making said survey, and the amounts thereof; which tabular statement is hereto attached and made a part hereof marked "Exhibit 4"

Where said Public Ditch or its branches runs along or across, or drains, any public or corporate road or railroad I did set forth in the said report the size of the opening for the culvert under the said road or railroad and did suggest the material of which the culvert should be b built and did propose a plan for said culvert which is marked "Exhibit 6"
