In the matter of the petition of M. C. Blanchett and others for a public ditch in the County of Anoka, State of Minnesota:

WHEREAS, A petition has been filed bearing date the 29th day of October, 1907, praying for the establishment of a public ditch in said County along the route described in said petition, together with a proper bond accompanying the same, and said petition has been heard and considered by the Board of County Commissioners of said County at their meeting held on the 5th day of December, 1907, pursuant to a notice of said hearing duly published and posted, as by law required, and the said Board of County Commissioners have appointed a competent civil engineer, to-wit, J. E. Hill, to make a complete survey of said ditch and of the route thereof, who has on the 2nd day of September, 1908, filed his report of said survey in my office, and the Board of County Commissioners has appointed M. I. Taplin, G. W. Wyatt and M. S. Seelye to be viewers of said proposed ditch by their order filed in my office the 4th day of December, 1907; and
