A petition will be presented to the County Commissioners at their next meeting on March 4<sup>th</sup> 1889 asking for the location and establishing of a public ditch commencing as a main line of in a marsh in the S.E.  $\frac{1}{4}$  of Sec. 6 in T-32-R-23 in Anoka County - thence in a westerly & northerly direction through said Sec. 6 also through Sec's. No 1 & 2 - 3 - 10 - 11 - 12 - T-32 R-24 to the North line of said Sec. 3 and terminating in Clark's Brook so called as its outlet - Also a branch commencing in a marsh in the N.E.  $\frac{1}{4}$  of said sec. 6 - T-32 - R-23. thence in a generally westerly and southerly direction through said Sec. 6 T-32 - R-23. and also through Sec. 1 and 2 - T-32 - R-24. and terminating in main ditch in said Sec. 2. Also a branch commencing in a marsh near center - S.W.  $\frac{1}{4}$  Sec. 12 - T-32 - R-24 and thence westerly and easterly through said Sec. 12 - And connecting with above main line near the south quarter post of said Sec. - also a branch commencing in a marsh near the center of Sec.  $\frac{1}{4}$  Sec 14 - T-32 - R-24 thence westerly and northerly through Sec's. No 14 - 11 in said T and R - to intersect - said main line near the north west corner of said Sec 11 and thence terminating.
