

Public Ditch in the County of Anoka, State of Minnesota:

WHEREAS, A petition has been filed bearing date the 28th day  
of July, 1909, praying for the establishment of a public ditch in  
said county along the route described in said petition, together with  
a proper bond accompanying the same, and said petition has been  
heard and considered by the board of County Commissioners of said  
County at its meeting held on the 4th day of April, 1910, pursuant  
to notice of said hearing duly published and posted as by law re-  
quired, and the said Board of County Commissioners has appointed a  
competent civil engineer, to-wit, J. E. Hill, to make a complete  
survey of said ditch and of the route thereof, who has on the 29th  
day of June 1910, filed his report thereof in my office and the
