This is to certify that I have examined the work on  
County Ditch No. 53 in your County, which work was contracted by  
Rood Construction Company.

I respectfully report that the ditch is partially completed  
as follows:- *Main Ditch from Station #57 to Station  
#37 and Tile from Station 146+50 to 144+80,-  
Extra yardage on tile work 455.7 Cu. Yds, @ 70¢  
Branch ditch #5 from Station # 58+91 to Station # 19+00  
and Lateral #2 of Branch #5 Completed,*

The excavation of said ditch is practically complete between  
said stations. Excavation *29510.4* . . . cubic yards. The  
said contractor has performed work on the above sections to the sum  
of *\$3327.94* . . . . . and he is entitled to a payment of  
seventy-five (75) per cent of the said amount, or the sum of . . . .  
*2495.94* . . . . is now due the said contractor from the  
ditch fund of the said Anoka County, and that no loss will result  
to the said County by the payment of this amount.
