

It is further ordered, That the County Auditor be, and he is, directed and required to give two weeks published notice of the time and place when and where we will meet to receive bids and let contracts for such repairs, to-wit: Aug. 31<sup>st</sup> 1915 at the auditor's office.

It is further ordered, That the cost thereof be apportioned and assessed to the lands originally assessed for its construction, in the same proportion as such original assessment.

In the Matter of the Petition of Daniel Peebles and Others, for the Repair of County Ditch No. 53

The above entitled matter came on duly to be heard by and before the County Board of Anoka County, State of Minnesota, at a meeting of said Board, duly called for the purpose of hearing and considering the petition for the repair of said ditch and the apportionment and assessment of the cost thereof, on the 12th day of July, A. D. 1915, at 10:30 o'clock A. M., of said day, and after hearing all the interested parties present the hearing was adjourned to July 19, 1915, and the engineer instructed to prepare a supplemental report in conformance to the wishes of the taxpayers, which report was presented at the meeting held July 19, 1915, and duly considered, and it appearing by proper evidence that due notice had been given of the pendency of said petition and of said time of hearing thereon, and that James Corr the Civil Engineer appointed by this Board to ascertain the cost thereof, has completed his work and duly filed his report thereon in the office of the County Auditor of said County.

said County Board did, at the time above specified, proceed to hear said petition and said Engineer's report thereon; and said Board having duly considered said petition and heard all the parties interested for or against the repair of said ditch and all other matters pertaining thereto, find as follows, to-wit:

FIRST—That said Civil Engineer has completed his work and made and filed his report thereon in all respects according to law.

SECOND—That notice of this hearing of said petition and of said Engineer's report has been duly given, published and posted and mailed as by law required, and that proofs of said service of said notice have been duly made and filed in the office of the County Auditor of said County, and that all other proceedings in the matter have been made and taken in accordance with the provisions of law.

Now, Therefore, As conclusions from the foregoing findings, we, the County Board of the County of Anoka State of Minnesota, at said session of said Board, held at the time above specified, being satisfied that the proposed repair of said ditch is necessary for its maintenance and usefulness for the purpose for which it was constructed, and to enhance its usefulness for the purpose of drainage, do hereby order and direct that said ditch be repaired as prayed for in said petition and according to the report and the specifications of said Civil Engineer made and filed herein:
