Auditor's Notice of Hearing.

State of Minnesota, ss. County of Anoka.

In the matter of the petition of E. L. Gilbert and others for a public ditch in the county of Anoka, state of Minnesota:

Notice is hereby given, that a petition has been filed in the office of the county auditor of the said Anoka county, Minnesota, praying for the construction of a public ditch through the following lands and accreted in the engineer's report as follows:

MAIN LINE The main ditch begins at station zero (0) which point is on the north line of the southeast quarter (se 1/4) of section fourteen (14), township thirty-one (31), range twenty-three (23) distant four hundred forty two (442) feet east from the one sixteenth (1/16) corner on the north line of said southeast quarter (se 1/4) of said section, on land owned by I. W. Smith et. al. and the main ditch runs thence west on the said one quarter (1/4) line, four hundred forty-two (442) feet to the northwest corner of the northeast quarter (ne 1/4) of the southeast quarter (se 1/4), thence south on the one sixteenth (1/16) line between the east half and the west half of the southeast quarter (se 1/4) of section fourteen (14), township thirty-one (31), range twenty-three (23) distant four hundred forty-two (442) feet over land owned by the said I. W. Smith et. al. to the one sixteenth corner on the south side of the southeast quarter (se 1/4) of said section fourteen; thence south 1/4 deg. e over the northeast quarter (ne 1/4) of section twenty-three (23) of said township and range, which land is owned by I. W. Smith et. al. and into the northeast quarter (ne 1/4) of the southeast quarter (se 1/4) of said section twenty-three (23) owned by F. G. Freishman, thirteen hundred thirty-eight (1338) feet to station one hundred three plus eleven and seven tenths (103 plus 11.7) in the southeast quarter (se 1/4) of the southeast quarter (se 1/4) of said section is southeast (se) corner of station twenty-three (23); thence south 47 deg. 30 min. east, into the northwest quarter (nw 1/4) of section twenty-five (25) of said township and range, a distance of ninety-two (92) feet to station one hundred four plus three and seven tenths (104 plus 3.7); thence south 1 deg. west; five hundred fifty-two (552) feet to station one hundred nine plus fifty-five and four tenths (109 plus 55.4); thence south 24 deg. 35 min. east to station one hundred fourteen plus eighty-three and eight tenths (114 plus 83.8) thence south 31 deg. 20 min. east, nine hundred eighty (980) feet to station one hundred twenty-four plus sixty-one and one tenth (124 plus 61.1) thence south 62 deg. 40 min. east, one hundred forty nine (149) feet to station one hundred twenty-six plus fifteen and three tenths (126 plus 15.3); thence south 69 deg. east; eight hundred thirteen (813) feet to station one hundred thirty-four plus twenty-eight and three tenths (134 plus 28.3); thence south 27 deg. 5 min. east, two hundred forty (240) feet to station one hundred thirty-eight plus sixty-eight (138 plus 68); thence south 17 deg. 30 min. west into the southwest quarter of said section twenty-five (25) two hundred twenty-eight (228) feet to station one hundred thirty-eight plus ninety-six and four tenths (138 plus 96.4); thence south 42 deg. 45 min. west, a distance of five hundred ninety-two and one tenth (592.1) feet to station one hundred forty-four plus eighty-eight and five tenths (144 plus 88.5); thence south 21 deg. 50 min. west, a distance of one hundred twenty-four and six tenths (124.6) feet to station one hundred forty-six plus thirteen and one tenth (146 plus 13.1); thence south 8 deg. west a distance of two hundred sixteen and nine tenths (216.9) feet to station one hundred forty-eight plus thirty (148 plus 30) thence south 10 deg. 30 min. east, a distance of eight hundred seventy-four and seven tenths (874.7) feet to station one hundred fifty-seven plus four and seven tenths (157 plus 4.7); thence south 42 deg. 50 min. east, a distance of seventy three and three tenths (73.3) feet to station one hundred fifty-seven plus seventy-eight (157 plus 78); thence south 73 deg. east, a distance of two hundred twenty-two (222) feet to station one hundred sixty (160) in the southwest quarter of said section twenty-five (25), township thirty-one (31) north of range twenty-three (23) west and there ending in Golden lake.

BRANCH NO. 1. Beginning at station zero (0), which point is west one thousand one hundred fifty one and two tenths (1151.2) feet from the northeast (ne) corner of section twelve (12), township thirty-one (31), range twenty-three (23); thence south 9 deg. west, on lands owned by Charles D. Ensign in the east one-half (1/2) of sec. twelve (12); thence continuing to station fifty-five plus thirty (55 plus 30) and thence south 49 deg. 59 min. west to station twenty plus seventy-eight and two tenths (20 plus 78.2); thence south 1 deg. 30 min. east, to station twenty-seven plus seventy-seven and seven tenths (27 plus 77.7); thence south 74 deg. 3 min. east to station thirty five plus eighty-three and five tenths (35 plus 83.5), thence south 4 deg. 30 min. east to station forty-one plus nineteen (41 plus 19), thence south 47 deg. 15 min. west to station sixty nine plus fourteen (69 plus 14) in the northeast quarter (ne 1/4) of the northwest quarter (nw 1/4) of section (13) in said township and range; thence on the said forty (40) acres owned by Charles Ensign, north 87 deg. 30 min. west to the west line of said northeast quarter (ne 1/4) of the northwest quarter (nw 1/4) continuing on the same course on the northwest quarter (nw 1/4) of the northwest quarter (nw 1/4) of said section thirteen (13) owned by John Flor to station eighty plus forty (80 plus 40); thence continuing on the same forty (40) acre tract, south 60 deg. 30 min. west to station eighty-one plus thirty-two (81 plus 32) and thence south 52 deg. west to station eighty-two plus thirty (82 plus 30) and thence south 31 deg. west to the south line of said northwest quarter (nw 1/4) of the northwest quarter (nw 1/4) of section (13) and continuing on the same course to the southwest quarter (sw 1/4) of the northwest quarter (nw 1/4) of section thirteen (13) owned by Maria Hensik to station ninety-nine plus seventy-nine (99 plus 79) on the west side of the road on the southeast quarter (se 1/4) of the northeast quarter (ne 1/4) of section fourteen (14) in said township and range owned by I. BRANCH NO. 5. Station zero (0) of branch ditch No. 5 is on the section line between sections fifteen (15) and twenty-two (22) of township thirty-one (31) north of range twenty-three (23) west, a distance of eighteen hundred eighty-three (1883) feet west of the corner of sections fourteen (14) fifteen (15) twenty-two (22) and twenty-three (23) in said township and range, running thence east along the said section line to station eighteen plus eighty-three (18 plus 83) at the corners of sections fourteen (14) fifteen (15) twenty-two (22) and twenty-three (23) aforesaid, thence east to station thirty-two plus three (32 plus 3) at the one sixteenth (1/16th) corner common to the southwest quarter (sw 1/4) of section fourteen (14) and the northwest quarter of section twenty-three (23) aforesaid thence east to station fifty-eight plus ninety-one (58 plus 91) and there ending in main ditch No. 53 at station thirty plus seventy-eight (30 plus 78) of said main ditch.

BRANCH NO. 6. Station zero (0) of branch ditch No. 6 is located nearly on the one sixteenth (1/16th) line between the southeast and southwest quarters of the southwest quarter (sw 1/4) of section twenty-three (23) in township thirty-one, north of range twenty-three (23) west, running thence north 54 deg. east to station seven plus seventy-four (7 plus 74) thence north 78 deg. east to station fourteen (14) plus 0 which station is south 2 deg. 30 min. east, 204 feet from the one sixteenth (1/16th) corner between the southeast and southwest quarters (se & sw 1/4) of said section twenty-three (23) thence continuing north 78 deg. east to station eighteen plus forty-four (18 plus 44) in the southwest quarter (sw 1/4) of the southeast quarter (se 1/4) of said section twenty-three (23) thence south 67 deg. east to station twenty-two (22) plus 0 thence south 33 deg. east to station twenty-six plus eleven (26 plus 11) there ending in main ditch No. 53 at station one hundred plus seventy and five tenths (100 plus 75.5) of said main ditch.

PEEBLES LATERAL TO BRANCH DITCH NO. 2. Station zero (0) of Peebles Lateral is located fourteen hundred sixteen (1416) feet west of and sixty-five (65) feet south of the northeast (ne) corner of section eleven (11), township thirty-one (31), range twenty-three (23) in Anoka county, running thence s 32 deg. west to station five plus forty eight (5 plus 48) thence s 9 deg. east to station ten plus ninety three (10 plus 93); thence s 23 deg. east to station sixteen plus thirty-one (16 plus 31); thence s 18 deg. east to station twenty-five plus fifty-nine (25 plus 59); thence s 13 deg. west to station twenty-nine plus eleven (29 plus 11) and there ending in branch ditch No. 2, at station one hundred two plus thirty-four (102 plus 34) of said branch ditch No. 2 and the northeast quarter (ne 1/4) of said section eleven (11).
