IN ANOKA COUNTY

For his Petition, James C. Marshall, Commissioner of Highways,
alleges as follows:

1. That this Petition is brought in accordance with Section 161.28, Minnesota Statutes 1959.
2. That County Ditch No. 54, Branch No. 3, is a duly established county ditch in Anoka County.
3. That Trunk Highway No. 10 is directly affected by Anoka County Ditch No. 54, Branch No. 3.
4. That it is advantageous and desirable in the construction and maintenance of Trunk Highway No. 10 that a minor alteration or change be made in that portion of County Ditch No. 54, Branch No. 3, described as follows:

Approximate Present Location of a Portion of
County Ditch No. 54, Branch No. 3:

Beginning at a point in present County Ditch No. 54, Branch No. 3, distant 363 feet west and 252 feet south of the east quarter corner of section 9, township 31 north, range 24 west; thence run southwesterly to a point distant 672 feet west and 586 feet south of said quarter corner; thence run westerly to a point distant 1036 feet west and 647 feet south of said quarter corner, and there terminating.

Approximate Proposed Location of a Portion of
County Ditch No. 54, Branch No. 3:

Beginning at a point in present County Ditch No. 54, Branch No. 3, distant 363 feet west and 252 feet south of the east quarter corner of section 9, township 31 north, range 24 west; thence run southwesterly to a point distant 628 feet west and 540 feet south of said quarter corner; thence continue southwesterly to a point in present County Ditch No. 54, Branch No. 3, distant 890 feet west and 615 feet south of said quarter corner and there terminating.

5. That attached hereto, showing the minor alteration or change in County Ditch No. 54, Branch No. 3, petitioned for herein, are plans and cross-section sheets marked Exhibit "A" and a right of way map marked Exhibit "B", said exhibits made a part hereof by reference.

6. That said minor alteration or change will not affect the functioning nor impair the efficiency of said County Ditch No. 54, Branch No. 3, or any of its branches, or laterals, if any.

WHEREFORE, your petitioner prays that the County Board of Anoka County make its order allowing James C. Marshall, Commissioner of Highways, and petitioner herein to make said minor alteration or change as set out herein, and in accordance with plans and cross-sections marked Exhibit "A" and right of way map marked Exhibit "B", attached hereto and made a part hereof by reference.
