## Notice to Ditch Contractors

Notice is hereby given that on July 20, 1916, at 10:30 o'clock a. m. the board of the county commissioners will receive bids at the auditor's office in the court house in the City of Anoka for the work of constructing county ditch No. 56 pursuant to their order dated June 14, 1916. Bids are invited for the work as one job, also for one or more lineal sections thereof, each of which sections is 100 feet long and numbered as shown by the engineer's report. Said work to be completed within the time required and in the manner specified in said engineer's report. No bid will be entertained which exceeds 30 per cent over and above the engineer's estimate.

The successful bidder will be required to enter into a contract and give a satisfactory bond in a penal sum of not less than the contract price, with not less than two freehold sureties, payable to the county of Anoka, for the use of said county, and also for the use of all persons who may show themselves aggrieved or injured by any breach thereof or of the contract for which said bond is given.

The said order and the engineer's report, estimates and profile are on file and may be seen in the office of the county auditor at the court house in the City of Anoka.

The estimated amount of work to be done and the estimated cost thereof is as follows:

The sale of jobs shall be public and all bids must be accompanied by a certified check payable to the county auditor of said county for not less than ten percent of the amount of said bid.
